

Privacy policy

Projektengagemang Sweden AB and its subsidiaries will always follow the prevailing legislation on privacy, which includes the EU General Data Protection Regulation (2016/679/EU) that came into effect on 25 May 2018. The present privacy policy explains how we use personal data that are submitted to us or that we collect. The policy is published online at www.pe.se

Projektengagemang may process your personal data if you enter into an agreement with Projektengagemang, or before Projektengagemang enters into an agreement with you.

Projektengagemang may also process your data if you represent a legal entity with which Projektengagemang has entered into – or may enter into – an agreement.

In addition, Projektengagemang may process your personal data if you contact us via our website, with a view to handling your enquiry.

In the absence of any specific statement to the contrary in this policy, Projektengagemang will not share your personal data with any third party without obtaining your explicit consent in advance.

Projektengagemang may therefore process some of or all the following personal data:

- Name
- Personal identification number
- Address
- Email address
- Phone number (mobile and/or landline)
- Employer, including company registration number

If you contact Projektengagemang by phone, letter or email, we may store the correspondence, which may contain personal data.

Purpose and legal basis for the processing

Projektengagemang processes your personal data to allow Projektengagemang to complete agreements concluded between you and Projektengagemang, or to perform actions at your request prior to entering into the agreement (EU General Data Protection Regulation, Article 6.1 b).

Projektengagemang also has a legitimate interest in processing your personal information to supply information and marketing about Projektengagemang and the business it conducts (EU General Data Protection Regulation, Article 6.1 f). You always have the right to decline marketing from us by clicking the link that is always included in our email mailshots, or by contacting us using the details presented below.

Projektengagemang may also process your personal data to the extent Projektengagemang is obliged to do so on account of legislation or decisions from authorities (EU General Data Protection Regulation, Article 6.1 c).

In order to enter into an agreement with Projektengagemang you are required to provide the personal data requested. Projektengagemang cannot enter into an agreement with you or the legal entity you represent without this information.

Receiver of information

Projektengagemang may commission a data processor to process personal data in the form of storage of the data, and/or through the operation and support of our systems. The processor may also read and organise the data, and transfer them on instruction from Projektengagemang.

The processor only stores your personal data on servers located within the boundaries of the EU/the EEA, and which are controlled by the Processor.

In the event that personal data are transferred to a third country, this will only involve such countries as the EU Commission has decided provide an adequate level of protection, or to other countries where appropriate security measures have been adopted in accordance with the EU General Data Protection Regulation, such as, for example, the receiving organisation or company having joined the EU-US Privacy Shield programme, or having signed standardised data protection provisions.

Storage and processing

Projektengagemang will process your personal data on the basis of concluded agreements during the period the agreement remains in effect, and for such time thereafter as may be necessary to fulfil obligations under the agreement between you and Projektengagemang.

Projektengagemang will then save such data as Projektengagemang is required by law to save – bookkeeping material, for example – for the period stipulated in law or decided by the authorities.

Projektengagemang will save contact details for the purposes of marketing and information for a period of five years after the most recent contact, unless you inform Projektengagemang that you no longer want to receive such information or marketing. Projektengagemang will then immediately delete such personal data as may be processed for this purpose.

Your rights

You have the right to request confirmation that Projektengagemang is processing your personal data, as well as access to these personal data as stipulated in the EU General Data Protection Regulation.

You are also entitled to request rectification of your personal data, as well as deletion of personal data or restriction of the processing (if grounds for such exist under the EU General Data Protection Regulation). You also have the right to request an extract of the personal data you have provided in a structured, commonly used and machine-readable format (portability).

Moreover, you have the right to submit complaints regarding our processing of your personal data to the supervisory authority, www.datainspektion.se.

Please note that we will perform an identity check on all requests of the type stated above to ensure that any measures requested are correct and in accordance with the law.

Security

Projektengagemang processes your personal data in compliance with the principles that derive from the EU General Data Protection Regulation (Article 5). Projektengagemang processes your personal data in a manner which ensures that suitable technical and organisational measures are adopted to protect your personal data against unauthorised access or unauthorised processing, as well as against loss, destruction or unintentional damage.

Projektengagemang uses secure servers where your data are processed, and limits access to personal data within the organisation. Authorisation to access personal data is only granted to individuals within the organisation, at the Processor and at this party's sub-processors, with the exclusive purpose of allowing these parties to perform their work assignments.

Amendments to this privacy policy

Projektengagemang reserves the right to amend the present privacy policy as and when necessary – to accommodate changes in laws and regulations, for example. Notification of any such amendments will be published on the Projektengagemang website.
